- Barnaamijkayaga aasaasiga ahi waa lacag la'aan waana khadka dhanka sharciga ah oo qarsoodi ah qof walba oo kirayste ah oo reer Minnesota ayaana la soo xiriiri kara si uu u helo talo dhanka sharciga ah oo khaas u ah xaaladiisa iyadoo 4 looqadood ah.






