## What is HOME Line?

## City Ordinances

#### Disclaimer

- There's a lot of cities in Minnesota
- Only covering recent ordinances in Saint Louis Park, Minneapolis, and Saint Paul
- Let us know if you know of other cities with new landlord-tenant ordinances



#### State Pre-Eviction Notice

- At least 14 days
- Required information (no required form)
- Minn. Stat. 504B.321, subd. 1a
- Cities can require longer time periods
- (At least 30 days under the CARES Act)



#### **SLP Pre-Eviction Notice**

- At least 30 days (up from 7 days)
- Use the Saint Louis Park's form
- Effective November 1, 2024
- Saint Louis Park City Code Section 8-335



#### **MPLS Pre-Eviction Notice**

- At least 30 days (up from 14 days)
- Other requirements remain the same
- City has a form, but it's not required
- Effective date March 1, 2025
- Minneapolis City Code 244.2060



### MPLS Prelease Disclosures

- Contact information (physical address)
- Rental property license tier and code violations
- Waste and recycling information (in multifamily buildings)
- Tenant can terminate lease as penalty

### MPLS 90 Days Disclosures

- Tenant rights information
- Minneapolis regulatory services contact information
- Other information deemed necessary
- No tenant specific penalty, but the city can enforce



### MPLS Disclosure Continued

- Effective date March 1, 2025
- Minneapolis City Code 244.2000 (8)-(9)
- Minneapolis City Code 244.2150 (city enforcement)



### MPLS Protected Classes

- Added several protected classes
- Revised several protected classes
- Added Exceptions
- Effective August 1, 2025
- Minneapolis City Code 139.10-141.60



## MPLS Height and Weight

- Numerical measurements of body size
- Impressions of a person as tall or short
- Impressions of a person's weight



### MPLS Housing Status

• The state of having or not having, a fixed, regular, and adequate nighttime residence



### MPLS Familial Status

- Minors
- Individuals who lack the ability to meet essential requirements for physical health, safety, or self-care



## SP Rent Cap Rollback

- Properties built after December 31, 2004, or that became residential after December 31, 2004, are exempt
- Saint Paul City Code 193A.08



#### SP Tenant Protections

- A number of tenant protections were passed
- Saint Paul City Code Chapter 193 is effective one year from the date of signing
- City has some work to do first
- Saint Paul City Code Chapter 193



#### SP Pre-Eviction Notice

- At least 30 days notice
- Saint Paul City Code 193.04



## SP Security Deposits

- Security deposits capped at one month
- Prepaid rent capped
- Double deposit exception
- Saint Paul City Code 193.02



## SP Applicant Screening

- Application fee Limit
- Screening criteria limitations
- Individual assessments
- Saint Paul City Code 193.03



### SP Relocation Assistance

- Limited for-cause protection after sale
- Notice required
- Relocation assistance required
- Limited to Affordable Housing Units
- Saint Paul City Code 193.05-6
